The Child Development Associate (CDA) Credential™ is the most recognized professional development benchmark for family child care providers, center-based or school setting staff. The national Council for Professional Recognition administers the CDA program and awards the CDA Credential to students that complete the program requirements.

What are the qualifications?

Individuals who earn the credential must:

- Be 18 or older
- Hold a high school diploma or equivalent
- Have 480 hours of experience working with children over the past 5 years

What do I have to do to earn the CDA credential?

Candidates for the CDA credential must complete:

- 120 hours of education in specific topic areas (CDA classes apply)
- A CDA Professional Portfolio
- A CDA Observation Visit by an approved early childhood specialist

How much does the CDA course cost?

- The CDA Course Fee is \$1,500
- A \$50 Registration fee is required to be submitted with a completed application; this fee will be applied toward the course fee
- All students will receive a Payment Plan to manage fees over the length of the course
- Financial assistance you receive through CSEA/VOICE or EIP will be applied toward the payment
- All fees must be paid in full by course end date

Financial assistance is available:

- 1. Family or Group Family child care providers may qualify for full scholarship through **CSEA/VOICE**. To obtain your ID number visit their website at http://voicecsea.org/professionaldevelopment.
- 2. Scholarship funding may also be available through the **Educational Incentive Program (EIP)**. For more information or to apply go to ttps://www.ecetp.pdp.albany.edu/eip.aspx.
 - If applying for an EIP Award for the first time you will be required to create an account. Your e-mail is your username and your password must fit the requirements requested. (After creatingyour Account save this information for future use and to check your account status).
 - To qualify you will need the class information below and required documents submitted to PDP(1040 Fed tax form and pay stub to verify gross income and employment).
 - Day Care Center Staff need the Center's License number and expiration date
 - Group/Family Child Care Providers need a copy of their Registration/License
 - You are responsible to follow up on your EIP application status within 2 weeks after applying. If you have difficulties you must call 800-295-9616 for help.
 - EIP Awards are mailed to your home address. You must sign / date the award and mail it to us as soon as possible so it can be applied to your account balance. Child Care Solutions must receive the original EIP Award; faxing or emailing this document will not be accepted.

Understanding the Financial Responsibility of your CDA Course
